4b (Code:) (Expenses \$ 63,100. including grants of \$ 55,892.) (Revenue \$) Scholarships awarded to qualified students in the Naperville School District 203 for educational related expenses associated with a college degree granting program.

4c (Code:) (Expenses \$ 55,251. including grants of \$ 48,043.) (Revenue \$) Study Skills Academy (SSA) is NEF's signature program, now district-wide, that grew out of an annual award-winning proposal piloting the establishment of an SSA in our 14 elementary schools. Today, NEF provides funding to 21 of our 22 schools for their before/after school program that gives students a boost with homework and learning strategies. SSA has been credited with helping to raise District 203 test scores.
